# CONSIDERATION OF DESIGN CONTRACT WITH BG CONSULTING FOR WATER MAIN REPLACEMENT

The project will consist of approximately 5,450 feet of new HDPE pipe to replace mostly 6 inch cast iron. Fire protection will be extended along 16<sup>th</sup> St from Cherokee to Choctaw St. The design fee is not to exceed \$120,000 including \$10,000 for construction services as needed during construction. Upon motion from Director Norris, seconded by Director Daniels, the motion passed 5-0.

**RESOLVED (No. 15090),** that the Board authorized the General Manager to award the design contract Waterline Improvements Cherokee Street from 12<sup>th</sup> to 20<sup>th</sup> to BG Consultants at a not to exceed cost of \$120,000.
