A. PAYROLL DISBURSEMENT OF MAY 31, 2018

The payroll for the period ending May 31, 2018 amounting to gross pay of \$84,741.77 (composed of the following withholdings and deductions) Federal Income Tax - \$6,834.52; FICA-\$6,343.67; State Tax - \$3,299.80; KPERS -\$4,978.84; KPERS-back \$113.63, Insurance - \$2,406.13; United Way - \$139.50; Eq-flex - \$1,476.74; PEDC - \$2,447.50; Garnishment - \$260.00; Misc - \$242.50, Optional Group Life \$351.34 and Deposit - \$55,847.60 including the following overtime amounts: Distribution 85.50 hours @ \$2,750.24; North Plant 9 hours @ \$273.81; South Plant 7 hours @ \$239.19 be approved and disbursements made from the Revenue Fund for their respective amounts.

PUBLIC HEARING ON KPWSLF LOAN FOR HORIZONTAL COLLECTOR WELL In accordance with a Notice published on April 26, 2018 in the Leavenworth Times, a newspaper of general circulation in the City, a public hearing was held by the Governing Body relating to a proposed loan in an amount not to exceed \$6,900,000.00. The "Loan" to be taken by the Leavenworth Waterworks Board from the Kansas Public Water Supply Loan Fund (the "Fund") administered by the Kansas Department of Health and Environment ("KDHE") pursuant to K.S.A. 65-163c *et seq.* Proceeds of the Loan would be used by the Waterworks Board to finance certain modifications and improvements (the "Project") to the City's water supply and distribution system (the "System").

The Chairman informed those present of the issues involved in the Governing Body making a decision whether to proceed with the Loan process, including entering into a loan agreement (the "Loan Agreement") with KDHE to fund the Project. Information regarding the scope of the Project, the proposed Loan repayment terms, the covenants proposed to be contained in the Loan Agreement and other relevant matters were discussed by the Chairman and Waterworks staff.

Members of the public were permitted to make statements and ask questions of the Governing Body and the Waterworks staff. After all present were given an opportunity to speak and ask questions, the Chairman closed the public hearing.

RESOLUTION ON KPWSLF LOAN FOR HORIZONTAL COLLECTOR WELL

The matter of proceeding with the application process came up for consideration and was discussed. Thereupon, Director Kaaz presented and moved the adoption of a Resolution entitled:

RESOLUTION NO. 14881

A RESOLUTION AUTHORIZING THE COMPLETION OF AN APPLICATION TO THE KANSAS DEPARTMENT OF HEALTH AND ENVIRONMENT REGARDING A LOAN FROM THE KANSAS PUBLIC WATER SUPPLY LOAN FUND

WHEREAS, the Leavenworth Waterworks Board of Leavenworth, Kansas (the "Board") is a duly authorized Board organized under laws of the state of Kansas (the "State") which operates a public water supply and distribution system (the "System"); and

WHEREAS, the Leavenworth Waterworks Board (the "Governing Body") of the Leavenworth Waterworks heretofore determined in to be in the best needs of the customers of the System to undertake certain modifications and improvements (the "Project") to the System; and

WHEREAS, the pursuant to K.S.A. 65-163c *et seq.* (the "Act"), the Kansas Department of Health and Environment ("KDHE") administers the Kansas Public Water Supply Loan Fund (the "Fund") from which loans are made to certain qualified Municipalities (as said term is defined in the Act) to finance modification and improvements to public water supply systems; and

WHEREAS, the Board has heretofore made an application to KDHE for a loan in an amount not to exceed \$6,900,000.00 (the "Loan") to finance the Project; and

WHEREAS, the Governing Body has conducted a public hearing this date on the advisability of proceeding with the completion of the application for the Loan and desires to authorize the appropriate officials of the Leavenworth Waterworks Board to accomplish the completion process.

BE IT RESOLVED BY THE GOVERNING BODY OF THE LEAVENWORTH WATERWORKS OF LEAVENWORTH, KANSAS, AS FOLLOWS:

Section 1. Loan Application. The Chairman and Secretary of the Waterworks Board are hereby authorized to cause to be prepared and to execute a Loan Application, including all attachments thereto (jointly, the "Application"); in substantially the form presented to the Governing Body this date, in order to provide financing for the Project. The Application shall be forwarded to KDHE as soon as possible.

Section 2. Further Proceedings. The Chairman, Secretary and other officers and representatives of the Waterworks Board are hereby authorized and directed to take such other action as may be necessary to complete the Application and to coordinate processing of a loan agreement for the Loan (the "Loan Agreement"); provided that the authorization to execute the Loan Agreement shall be subject to further resolution of the Governing Body.

Section 3. Further Authority. This Resolution shall be in full force and effect from and after its adoption.

CONSIDERATION OF KMU MUTUAL AID PROGRAM The State of Kansas has experienced a number of disasters and emergency situations over the last several years that have caused significant damage to the utility infrastructure across the state. A coordinated effort has been developed to provide assistance to those affected utilities when the necessary response outstrips the utilities' ability to respond on their own. The Kansas Mutual Aid Program (KSMAP) has been developed to serve as the mutual aid program for Kansas utilities.

KANSAS MUTUAL AID PROGRAM FOR UTILITIES (KSMAP) RESOLUTION NO. 14883

WHEREAS, the Leavenworth Waterworks Board ("Utility"), owns, operates and maintains a water utility:

WHEREAS, the Leavenworth Waterworks Board desires to cooperate with other cities, districts, and utilities which own and operate water, wastewater, gas, and/or electric utility systems;

WHEREAS, the Utility expresses its intent to encourage and foster mutual aid between and among utilities in the event of disasters and emergencies;

- WHEREAS, the Federal Emergency Management Agency ("FEMA") has established a rule with which provides the FEMA will reimburse mutual aid costs for a particular disaster or emergency only if mutual aid participants have signed a written agreement prior to that disaster or emergency;
- **WHEREAS,** prudent and appropriate charges should be established from time to time which may be paid to the Utility for its provision of mutual aid assistance to the Utility;
- WHEREAS, participation in the program and responding to a request for assistance is strictly voluntary. The adoption of this agreement does not obligate the city, utility, district or association to provide any and all assistance that may be requested by another utility.

NOW, THEREFORE BE IT RESOLVED by the board of directors of the Leavenworth Waterworks Board that:

- **Section 1.** The General Manager is hereby authorized and directed to execute and deliver the Kansas Mutual Aid Program (KSMAP) Agreement (attached hereto) and such other documents and agreements as may be necessary for participation in the Kansas Mutual Aid Program for utilities.
- **Section 2**. The managing staff of the utility system(s) shall establish reasonable rates for reimbursement of its labor and equipment costs as contemplated in FEMA rules, and periodically revise such rates as necessary.
- **Section 3**. The Utility will provide mutual aid assistance to other like utilities if the management of the Utility determines that:
 - (a) The reliability and performance of the Utility's system(s) and the public health and safety of the Utility's residents and customers will not be materially and adversely affected; and
 - (b) The utility requesting assistance has executed the Kansas Mutual Aid Program Agreement (or an agreement substantially similar in form and content).
